The City of West Linn formed the West Linn Library Foundation to further support for the West Linn Public Library. In June 2010, the Foundation received tax-exempt status from the Internal Revenue Service.

The Foundation operates under laws governing non-profit organizations, including those of the Internal Revenue Service, Oregon Department of Justice, and Oregon Secretary of State. West Linn Library Foundation Bylaws and Financial Management Policy guide board actions.
